# CODE OF CONDUCT/WAIVER OF LIABILITY

## for

### JR. LIVESTOCK SHOW EVENTS

A primary goal of Jr. Livestock Shows is to build character in youth while participating in them. Jr. Livestock shows promote the CHARACTER COUNTS!™ six core ethical values: trustworthiness, respect, responsibility, fairness, caring and citizenship. The following Code of Conduct is designed to assure that the Jr. Livestock show provides a positive environment for all individuals to develop character:

#### Trustworthiness

- \* I will be worthy of trust, honor and confidence.
- \* I will keep my commitments by attending all sessions of the planned event. If I am not feeling well or have a scheduled conflict, I will inform my chaperon or a person in charge.
- \* I will be in the assigned area (e.g., dorms, buildings, etc.) at all times.
- \* I will be a model of integrity by doing the right thing even when the cost is high.
- \* I will be honest in all my activities. Livestock shows do not permit dishonesty by lying, deception or omission.

#### Caring

- \* I will be caring in my relationships with others.
- \* I will help members in my group to have a pleasant experience by striving to include all participants.
- \* I will be kind and show compassion for others.
- \* I will treat others the way I want to be treated.
- \* I will show appreciation for the efforts of others.

#### Citizenship

- \* I will be a contributing and law-abiding citizen.
- \* I will follow the hours and room rules established for the event.
- \* I will not use any illegal substance (e.g., tobacco, alcohol or non-prescriptive drugs.)
- \* I will be respectful to the environment and contribute to the greater good.

#### Responsibility

- \* I will be responsible, accountable and self-disciplined in the pursuit of excellence.
- \* I will live up to high expectations so I can be proud of my work and conduct.
- \* I will be on time to all program events.
- \* I will be accountable by accepting responsibility for my choices and actions.
- \* I will be responsible for any damage, theft or misconduct in which I participate.

#### Respect

- \* I will show respect, courtesy and consideration to everyone, including myself.
- \* I will dress appropriately and tastefully at all events.
- \* I will act and speak respectfully. I will not use vulgar or abusive language.
- \* I will treat program areas, lodging areas and transportation vehicles with respect.
- \* I will appreciate diversity in skill, gender, ethnicity and ability. Livestock Shows do not permit statements or acts of prejudice.

#### Fairness

- \* I will be just, fair and open.
- \* I will participate in events fairly by following the rules and not taking advantage of others.

I have read the Code of Conduct and agree to live up to these expectations. I am aware that all my actions and decisions affect others. I realize that my failure to act with good character could result in loss of privileges during the event, or for future events. I am willing to accept the appropriate and logical consequences of my actions. As a participant in a Jr. Stockshow event, I release the Stockshow Officials, State Extension programs and personnel, FFA Advisors and all those affiliated with the Stockshow from liability should I accidentally be injured due in part to my own negligence.
